

Nebraska Actuaries Club

2001 - 2002

The third meeting of the 2001-2002 Club year for the Nebraska Actuaries Club was held on April 4, 2002 at the Holiday Inn Downtown in Lincoln.

The featured speakers for the meeting were Daniel J. McCarthy, President of the American Academy of Actuaries and Harry H. Panjer, President-Elect of the Society of Actuaries. Mr. McCarthy spoke to the group about the structure and initiatives of the American Academy of Actuaries, professionalism and the Academy's role in shaping public policy. Mr. Panjer provided information on the history of the profession, strategic issues facing the profession and current and future activities of the Society of Actuaries.

Club President Scott Herchenbach opened the business portion of the meeting. There was no old business to report. Guests attending the meeting were introduced, including students from the UNL and UNO actuarial programs. The Nominating Committee announced their nominees for the 2002-2003 Club year. For the position of Secretary/Treasurer, they are Max Rudolph of Mutual/United of Omaha and Valerie Lendt of World Insurance. For Board of Director the nominees are Ron Kuehn of Ameritas/Acacia and Ernie Foerster with Security Financial Life. Nominations were opened to the floor, but none were received.

Scott announced that the next meeting would be the R&R day scheduled for June 10th at Tregaron Golf Course in Bellevue.

There being no further new business, Scott thanked the speakers and members of the program and arrangements committees and the meeting was adjourned.
