Program Committee Meeting Minutes August 2, 2002

Marv will contact the SOA office to make arrangements for the SOA President. An additional speaker for this meeting was also discussed, with the president of the AAA, someone from the SOA E&E committee, or Teri Vaughan, Iowa Insurance Commissioner mentioned as possibilities. Marv and Jen will recruit the speakers for this meeting.

Brice will be in charge of the R&R meeting targeted for the first Monday in June. He will investigate several golf courses to see what is available to us.

The facilities arrangements will be made by Stephanie Noonan in Omaha and Adam Johnson in Lincoln.
